




Returning God's Blessings

Linda will share a variety of choices available to you in developing your plan, such as charitable trusts, gift annuities, donor advised funds and endowments. She will also give a general overview of other planning techniques like wills and living trusts, and help guide you through sensitive end of life planning and decisions.

Having a completed Christian estate/gift plan gives you peace of mind knowing that your wishes for the gifts God has entrusted to you are fulfilled. You can make gifts to loved ones, support your favorite ministries, and finalize sensitive life decisions through planned giving.



The Five P's of Planned Giving

Prayer

Ask for God's guidance in putting together a plan that will transfer your blessings entrusted to you to the people you love and the ministries you care about in a way that will be a blessing and bear fruit that will last.

People

Determine who will be included in your plans – family, heirs, friends, and others. Consider any special needs they may have that will be important to your planning.

Property

Record all the assets that God has entrusted to your care to determine the size of your estate, how the assets will transfer, and how laws affect your plan.

Plans

Talk about the plan that God has placed in your heart for your family and the Lord's work. We call this plan a Lifetime Plan for Giving[™].

Planners

List others who already assist you. You will continue to work with them to complete your plan, such as an attorney, CPA, and other advisors.

The Process

Through our planned giving process, we help you to establish a complete Christian estate/gift plan. We call this plan your Lifetime Plan for Giving[™]. There are four steps to guide and educate you through the process of developing and implementing your Lifetime Plan for Giving[™].

- 1. **Discovery** A simple survey documenting your estate preferences including stewardship goals, family relationships, financial blessings and desired tax advantages begins the process.
- 2. Design Using the information from the survey, several gift plan designs are created for your consideration by our Gift Planning Counselor. These designs reflect your estate planning goals and offer several options for you. They are in an easy to read one-page format.
- **3. Summary** When you choose a plan, our Gift Planning Counselor drafts an organized estate plan summary for delivery to your attorney and other professional advisors.
- **4. Implementation** The final step is implementing your Christian estate/gift plan. Your attorney will review, advise, and prepare the necessary legal documents. The counselor-provided summary will assist considerably in this process and in many cases can reduce legal costs.

Include a statement of faith in your will or trust.



A Christian Preamble is a way for you to begin your will or trust with a simple, personal statement of faith. It is a lasting opportunity to proclaim your love of the Lord to family and friends.

When planning a will or trust, many people focus only on distributing their money, property and possesions. A Christian Preamble allows you to share your true wealth: your belief in Jesus Christ and His gift of everlasting life.

A Christian Preamble is:

- A source of comfort to mourning family and friends. They are reassured that their loved one died in faith, sure of God's promise of eternal life.
- A powerful message of love and encouragement, urging others to trust in Jesus Christ and strengthen their own faith.
- A public record of Christian love (when used with a will). Because a will is filed in probate court, a Christian Preamble becomes a public record.

You can write your own Christian Preamble. Perhaps you want to include favorite Bible verses. You can offer your final prayers for loved ones, mentioning them by name and encouraging them to grow in faith.
